The Company subscribes to the requirements of MLC, ILO and ITF and supports the principles set out in the United Nations Universal Declaration of Human Rights.


Additionally, **DELTA TANKERS Ltd.** actively participates in **SHELL Partners in Safety** initiative for ZERO Incidents Industry since 2011.

The ultimate goal of ZERO Incidents is being incorporated in company HSQE Policy.







### **Technical Management**

All vessels were built under the supervision of **Delta Tankers Site Team** at First Class **Korean yards** (HHI, HSHI, DAEWOO, SAMSUNG) and highly reputable **Chinese yards** (NTS, JINHAI).

Vessels are of high-spec designs, fitted with equipment and systems which meet Class/Flag requirements and on cases exceed industry safety and environmental standards.

Twenty-three (23) out of total twenty nine (29) managed vessels are equipped with energy saving devices for energy efficiency and voyage optimization.

It is company's policy to apply silicone paint on propellers (except for Ice Class vessels) in order to ensure long-term efficiency with less fouling rate.





# **Technical Management**

Technical Department is responsible for the monitoring of the fuel consumption and the emissions related to the performance of the fleet thus ensuring sustainability and minimizing, to the extent possible, company's imprint to the environment.

LAROS tool is used for "real-time monitoring" of vessels' performance and energy efficiency.

The Technical Department drives innovation and supports Management, Chartering, Operations and Safety departments in the decision making process and risk mitigation.

DELTA TANKERS Ltd. is an ISO 14001:2015 "Environmental Management" certified company by Lloyds' Register.

At **DELTA TANKERS**, we are strongly committed to environmental sustainability.



**DELTA TANKERS** fleet is predominantly manned with seafarers from **Greece** and the **Philippines** whilst **Russian**, **Ukrainian**, **Romanian & Georgian Officers** are also included in the tanker-dedicated company pool.

The employment criteria for Officers meet or exceed the minimum mandatory requirements of the Flag Administration (Greece & Liberia) and those stipulated in MLC. Charterers' and TMSA requirements are incorporated in company practices.

The Company voluntarily subscribes to the principles of the **Green Award** initiative and holds a 3-year Green Award Certification.




